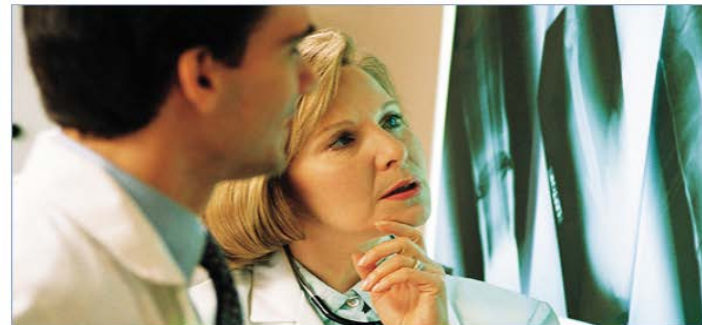

## Things to Know

- Scan documents/attachments before you start filling out application(Licenses, certifications, EFT forms, voided checks, IRS letter, etc.)
- Individual applications-ONLY the individual can sign application
- Individual's application can ONLY reflect the W9 of the individual's information
- Linking to a Group-The paper version of Section 4 must be printed, signed and uploaded with the attachments
- EFT Form must be completed for the enrolling provider ONLY
- Provider Enrollment cannot accept direct deposit sign up forms from Bank Websites, CMS Website or any other State Agency. ONLY Arkansas Medicaid Website
- ALL new providers must have an EFT on file or their application will not be approved
